## Review of Instructions on Bulk Deposits for Regional Rural Banks (RRBs)

Please refer to Para 3 (a) (i) of <u>Master Direction - Reserve Bank of India (Interest Rate</u> <u>on Deposits) Directions, 2016 dated March 3, 2016</u>, in terms of which "Bulk Deposit" means:

- i. Single Rupee term deposits of Rupees two crore and above for Scheduled Commercial Banks (excluding Regional Rural Banks) and Small Finance Banks.
- ii. Single Rupee term deposits of Rupees fifteen lakhs and above for RRBs.

2. On a review, it has been decided to enhance the bulk deposit limit for Regional Rural Banks. Accordingly, "Bulk Deposit" for Regional Rural Banks would now mean Single Rupee term deposits of Rupees one crore and above. The relevant sections of the Master Direction as amended are indicated in the <u>Annex</u>.

3. All other instructions in this regard shall remain unchanged.
